Organ: a keyboard instrument in which sets of pipes are sounded by compressed air and produce a variety of timbres

The purposes of the AGO are to advance the cause of organ and choral music, to increase their contributions to aesthetic and religious experiences, and to promote their understanding, appreciation, and enjoyment. To improve the proficiency of organists and choral conductors. # **Board Meeting Notes**

August 16, 2007. The meeting of the RRV AGO was called to order at the Boulger Funeral Home by Dean Victoria Wms Sieben.

Those present were: Susan Clambey, Ruth Discher, Michael Olson, Victoria Sieben, Ruth Strawn, Robyn Vinje.

#### Program Committee

Details for the Paul Jacobs Master Class and Recital on September 15th and 16th were discussed with Michael Olson, First Lutheran coordinator.

- -There will be a Master Class from 10am 12pm on September 15<sup>th</sup>. Peter Nygaard from Concordia and Bill Wojnar from Jamestown College will be asked to provide students for the class. There will be no admission charge for the Master Class.
- -Ruth Strawn, Treasurer, will be in charge of ticket sales at two entrances. Ruth D., Sue C., and Robyn V. will assist with ticket sales.
- -Michael O. will arrange for 4 church members to serve as ushers (with "Usher" tags) (2 at each entrance) to pass out programs and direct guests to seating, restrooms, etc.
- -Vicky S. will be available at the RRV-AGO booth with chapter and national organization information, including membership forms.
- -Michael O. will provide Vicky with the program and bio information for the recital.
- -Michael O. is taking care of making hotel reservations for Paul Jacobs and will pick him up at the airport.
- -Michael O. will check about CD sales—at this point we do not expect to have CDs for sale.
- Vicky will confer with Carolyn Hensrud about PR budget and plans, as well as poster distribution.
- -Michael O. will introduce Paul Jacobs at the recital.

Vicky distributed an example of a program survey from AGO for Board members to consider in the possible formulation of a survey to be included in the Pipeline. The objective of the survey would be to gather information as to the evaluation of current chapter events and interest in future program topics.

At this point, Michael O. excused himself from the meeting and Program Committee discussion continued:

<u>December 2, 2007 Carol Sing-a-long</u> will be held at Good Shepherd Lutheran, Moorhead. Carolyn Hensrud is the chairperson.

<u>February 3 or 10, 2008 Organ/Instrumental Program</u> – no further report-location undecided.

April 5 or 12, 2008 Piano to Organist Workshop co ducted by Sue Knorr will be at Dilworth Lutheran. Vicky S. will contact Sue K. to discuss her material and length of sessions.

May 4, 2008 Organ Crawl in Fergus Falls, MN has received response from First Lutheran Church. Lance John son and Sue Clambey will contact Augustana and Bethlehem Lutheran Churches and check into considering the Theater organ in the tour as well.

Robyn V. moved to approve the Minutes from the July 2007 Board meeting as written and distributed in the August Pipeline. Ruth S. seconded the motion and the Minutes were approved.

Ruth S. presented the Treasurer's Report: She deposited \$599.00 in membership dues. The checking balance is \$3,630.77 and the Money Market account balance is \$4591.96. Sue C. moved to accept the Treasurer's report. Robyn V. seconded the motion and it was carried.

Sue C. moved that the budget be approved as presented thus far. Robyn V. seconded the motion and it was carried.

## **Membership Benefits**

Where does your National AGO membership fee go? It pays for more than just a magazine subscription. Sometimes we don't realize all the benefits of our membership dollars at work. Here is an example:

#### CHAPTER LIABILITY INSURANCE

As liability insurance rates have increased dramatically in recent years, many organizations have cut their costs by not including the use of their facilities by outside groups in their liability insurance coverage. Such facilities, which your chapter may wish to use for program events (churches, school facilities, and concert halls) will require that your chapter carry its own liability policy for such events. Proof of such insurance will be required before use of space is approved.

The Guild has a group Chapter Liability Insurance Plan covering all AGO chapters. The plan is administered by Insurance & Risk Management. The plan covers all chapter activities, including regional conventions.

The policy provides the following comprehensive coverage:

- Claims for bodily injury or property damage
- Claims for personal injury, such as libel, slander, defamation of character, false arrest, etc.

- Claims alleging host liquor liability when alcohol is served
- Claims involving use of automobiles not owned by the chapter, but used for official chapter business on an excess basis.
- Claims alleging failure to render professional health care services by nonprofessional individuals

The Plan pays complete legal defense costs and settlement costs if a coverage charge is brought against your chapter - whether it results in a lawsuit, court judgment, or even out-of-court settlement.

Your chapter, its leaders, and any member acting on behalf of the chapter are covered under this comprehensive Chapter Liability Insurance Plan. The plan provides up to \$1,000,000 per occurrence and a \$2,000,000 annual aggregate to each chapter. There is no deductible.

If your chapter is told by a church or facility that it must provide proof of insurance before

scheduling an event there, copy and fill out the request form (see next page) and send it to Insurance & Risk Management, which will send the chapter a certificate verifying the coverage.

Ours has been described as a litigious age, in which everybody sues for everything. They don't always win, but it is good to know that your chapter is covered in case of accident or injury to anyone attending a chapter event.


