# **Board Meeting Notes**



The AGO Board met on Saturday, October 31 at noon at the Fargo Village Inn Restaurant. The following members were present: Peggy Johnson, Anna Goodin-Hayes, Bill Tweten, and Michael Olson.

The minutes of the September meeting were approved as submitted.

Bill presented the treasurer's report. The beginning checking account balance was \$6291.67. The following receipts were listed: membership dues of \$92, CD sales (from the September meeting) of \$12, ad revenue (for the PIPE-LINE) of \$200, and recital income (from ticket sales) of \$226. Receipts totaled \$530. The following expenses were listed: AGO dues of \$55, AGO Annual Fund of \$12 (the CD sales from the September meeting were designated to be sent to this fund), and \$2000 to Kim Kasling for the organ recital. Expenses totaled \$2067. The current checking account balance totals \$4754.67. The CD totals \$5648.51, giving us a grand total in both accounts of \$10,403.18.

The bill from the Radisson will be forthcoming. We tried to take care of paying the bill following the recital, but the Friday night billing doesn't take place until the middle of the night (as I guess is the case at most hotels).

We had quite a discussion about the Kim Kasling organ recital held on Friday evening, October 30 at First Lutheran Church. He played very well and was a very nice gentleman. His verbal program notes in-between pieces, as well as his printed program notes, were all very helpful. The ticket prices were not unreasonable at all. So, where were all the people?? Perhaps a Friday evening concert is not the best time for various reasons. Perhaps Kim Kasling was "too local" or not well-known (although most recitalists who have come for recitals have not necessarily been well-known to those beyond the organ community). The weather earlier that day may have played a role in people, especially from out of town, deciding not to come. First Lutheran had its annual lutefisk/meatball dinner the Friday before, on October 23, and four hundred people came and ate. Perhaps we need to combine food and music at the same time?! We did decide to cancel the master class because it was difficult to find people to perform. By canceling the master class, Dr. Kasling agreed to have us waive that \$500 fee.

We discussed the possibility of a "virtual chapter" in addition to what we traditionally do as a chapter. Being in a rural part of the country, perhaps something on this order would bring others who might not otherwise be able to be physically present at meetings and events. This might also be a way to get younger folks, including organ students, involved as well. This might be on the order of Facebook, a very popular online social network, or a Yahoo chat group.

We're each a pocket of isolation in our own church setting. We need to publicize ALL our events for each other. We are so busy in planning and practicing our events that we forget to publicize and let others know what we're doing.

We discussed recruitment of members, retention of members, and how to reach young people.

Anna has agreed to set up a Facebook page for our AGO chapter. This will be a safe environment for students and adults alike.

Organ students of Peter Nygaard will present a recital on Monday, November 16 at 7:00 p.m. at Trinity Lutheran Church in Moorhead. We will host a reception for the students and those attending the recital right afterwards in the church lounge. Come and meet the performers and have refreshments! Concordia will print the programs as this recital is an "official" Concordia recital.

We have decided NOT to have the annual Christmas Sing-A-Long this year. We have decided instead to have us promote our own church events and concerts and recitals. We just need to let Sheila know ASAP so she can publish them in the PIPELINE.

Sunday, March 21, 2010 "just happens" to be Bach's birthday. Specifically, it's his 325th birthday. We would like to do something, but aren't exactly sure what to do as of yet. A progressive musical event (going to several churches) and including food was all discussed. This will be discussed further.

Our next board meeting is Thursday, November 19 at noon at Boulger Funeral Home. Bring something to share with others for our potluck lunch.

### Pipe Organ Competition

The next Carlene Neihart International Pipe Organ Competition will be held on April 10, 2010 in Kansas City, Missouri at the Second Presbyterian Church. The 1949 Moller Pipe Organ has been rebuilt and restored in 2009 and includes a new movable console. Contestants from various places in the United States and in other countries are expected to enter the competition.

Quimby Pipe Organs, Inc., will underwrite the first place award (\$2500) and the second place award (\$1500) is sponsored by Casavant Freres and Caroll Hanson. The third place award is \$1000.

The Carlene Neihart Organ Competition Foundation, with a 501 (C) (3) tax-exempt status was formed to organize, present the competition and fund the prize money to help sustain the future of the Pipe Organ.


